

PRIVACY INFORMATION NOTICE

This is for children and young people who come to the Self Management workshops run by Children's Health Scotland. We will make sure to keep any information you give us about you safe. There is a law called the Data Protection Act 1998 and the EU General Data Protection Regulation (GDPR) which helps to keep us right about personal information.

What Information we hold	Why we hold this

How we store your information: Your personal information will be kept privately and securely. Only certain people in our organisation can see this. We will keep paper information in a locked cabinet and electronic information encrypted (password protected).

Sharing information - Sometimes we may have to share some information about you with other professionals (eg your specialist nurse or consultant). You have agreed we can share with them if we need to.

We will never share your personal information with any another third party unless noted here, unless we check with you first, or unless the law says we have to.

Your rights about your personal information - The GDPR law gives people certain rights about information held about them.

Self Management Project: Children and Young People

A person can ask an organisation to inform them about their personal information. This is what this privacy notice does. A person can ask an organisation to get delete their information; to change it if it is not right; to ask it not to be used any more or to limit its use. They can ask for a copy of the information, for it to be given back to them or given to someone else that they choose.

You can ask us to do any of this but first we will make sure you understand what you are asking. If we feel you don't or you are unsure then your parent or carer can ask for you.

There may be reasons why we cannot do some of what you ask but if so we will explain.

You have the right to complain to the (ICO) if you are worried about the way your personal information is being used if we aren't able to sort things out. www.ico.gov.uk

How long we keep information: We will keep your information for seven years after the end of our self management project. We will then delete it securely and confidentially. But you can ask us to remove it earlier than that. We will just make sure you understand what this means.

You don't have to give us any personal information because it is part of a contract or a law.
